PURPOSE

Reference to accreditation is expressed through various types of action and material means adopted by the accredited body to promote and claim accreditation status.

This covers:

- -Written and verbal communications in various communication media.;
- -Accreditation claims on reports and certificates issued by accredited bodies;
- -Accreditation claims on stationary paper and on other types of publicity and advertising material.

PAC accredited bodies are entitled to make reference to accreditation by using an accreditation symbol and/or by using appropriate words in accordance with the rules prescribed in this document.

Only endorsed reports or certificates bearing the accreditation symbol can benefit fully from the acceptance established through mutual recognition agreements

The purpose of this document is to set the rules governing the use and protection of its accreditation symbols and reference to accreditation by its accredited bodies.

2. SCOPE

This document describes for accredited conformity assessment bodies (CABs) and their customers the requirements of PAC for the use of accreditation symbols and reference to PAC accreditation;

4. DEFINITIONS

PAC: Somali Quality Control Department

ILAC: International Laboratory Accreditation Cooperation

CAB: Conformity Assessment Body

5. RESPONSIBILITIES

Accreditation Manager: to ensure that accredited CABs are informed of and comply with the requirements in this document

Quality Manager: to ensure that the requirements set in this document are in line with the specified in the relevant regional and international accreditation requirements.

6. POLCY

6.1 GENERAL REQUIREMENTS

6.1.1 Only PAC accredited bodies may use **PAC accreditation symbol** to make reference to accreditation. **PAC symbol** shall be differentiated from **PAC logo** which is used only by PAC to identify itself and it shall not be used by any other CAB or organization.

- 6.1.2 The PAC accreditation symbols shall be reproduced:
 - a) in the full-colour form or in the single colours detailed in Appendix B;
 - b) on a background that will not impede readability;
 - c) in a size that makes all features of the symbol clearly distinguishable;
 - d) without distortion of its dimensions and
 - e) only from the electronic copy provided by PAC to the accredited body.
- 6.1.3 The accreditation symbols shall be displayed
 - a) in conjunction with the relevant accreditation number as described in Appendix I;
 - b) only if the title or logo of the accredited body is also shown;
 - c) with no more prominence than the title or logo of the accredited body and
 - d) not more than once for each relevant PAC accreditation.

6.1.4 When an accredited body claims its PAC accreditation status using wording instead of PAC accreditation symbol, it shall state this reference using, without variation, the relevant phrase with **the accreditation number** as follows:

- "a PAC Accredited Testing Laboratory, No..."
- "a PAC Accredited Calibration Laboratory, No...."
- "a PAC Accredited Medical Laboratory, No..."
- "a PAC Multi-Accredited Laboratory, No..."
- "a PAC Accredited Certification Body, No..."
- 6.1.5 The Accredited body shall not use the accreditation symbols or make reference to its accreditation in a way that implies, or may lead to believe that the work is covered by the scope of accreditation when it is not.

The accreditation symbol and accreditation claims shall be used only:

- a) after accreditation is granted, the accreditation symbol shall not be used by applicants for accreditation;
- b) for the specific activities covered by the scope of accreditation.
- c) for the accredited premises and locations
- d) only under the name or the registered trade name of the legal entity in which it holds accreditation;
- e) accompanied by the organization's accreditation number.
- 6.1.6 The accredited body shall not make any misleading or unauthorized statement regarding its accreditation as to which conformity assessment activities are actually covered by the accredited body's scope of accreditation or use its accreditation in such a manner as to bring PAC into disrepute.
- 6.1.7 An accreditation symbol or an accreditation claim shall not be affixed on its own or used to imply that a product, process, service, management system or person has been certified or approved by PAC. (For example it is prohibited to use accreditation symbol on business cards or on product packaging material. For calibration/inspection/reference material labels, see clauses 6.3)
- 6.1.8 An accreditation symbol or an accreditation claim is not used in any manner which gives the impression that the accreditation body accepts responsibility for conformity assessment results, or for any opinion or interpretation derived from those results, or that the accreditation body approves a tested, calibrated or inspected product or item, or reference material (for requirements for accreditation symbols on calibration/inspection/reference material labels, see clauses 6.3)
- 6.1.9 Accreditation symbols shall not be placed on the products or items which have been subjected to conformity assessment (except on calibration/inspection/reference material labels, see Clause 6.3)

6.1.10 the accreditation symbol shall not be used by an accredited body's external service providers that are not accredited by the accreditation body;

6.1.11 Upon withdrawal or suspension of its accreditation, the accredited body shall

- a) stop issuing any documents bearing accreditation symbol and discontinue its use of any reference to that accreditation;
- b) informs its affected clients of the suspension, reduction or withdrawal of its accreditation and the associated consequences without undue delay. (e.g. a consequence for a customer of a certification body is the withdrawal of certificates issued by certification bodies under their scope of withdrawn accreditation)

6.2 REPORTING ACTIVITIES AND RESULTS NOT COVERED BY THE SCOPE OF ACCREDITATION

- 6.2.1 PAC accreditation symbols cannot be used, and that neither reports nor certificates nor any enclosed letters (including the paper on which they are printed) can include any reference to accreditation, if none of the results are for conformity assessment activities within the scope of accreditation;
- 6.2.2 Where any endorsed reports or certificates which contain, or are based upon, some results of conformity assessment activities not performed under the accredited body's scope of accreditation, the reported results or outcomes are clearly identified by a disclaimer (e.g. "The conformity assessment activities marked * are not covered by the scope of accreditation."; "The result/conclusion is based on conformity assessment activities outside of the scope of accreditation.")
- 6.2.3 There shall be nothing in any conformity assessment report or certificate or in any attachments or other materials that implies, or may lead any user of the results or any interested party to believe that the conformity assessment activity is covered by the scope of accreditation when it is not.

6.3 CALIBRATION LABELS, INSPECTION LABELS, REFERENCE MATERIAL DOCUMENTS AND LABELS, AND PROFICIENCY TESTING DOCUMENTS.

6.3.1 CALIBRATION LABELS ON EQUIPMENT

- 6.3.1.1 An accredited calibration laboratory may attach a calibration label containing the accreditation symbol to an item of equipment that it has calibrated using calibration methods covered by its scope of accreditation.
- 6.3.1.2 Calibration labels containing the accreditation symbol shall not give the impression that the accreditation body approved or calibrated the equipment.

- 6.3.1.3 The calibration label shall include the following information:
 - a) The name of the accredited calibration laboratory;
 - b) The accredited laboratory accreditation number;
 - c) The equipment identification;
 - d) The date of current calibration;
 - e) Cross reference to the calibration certificate issued in respect of the calibration

6.3.2 INSPECTION LABELS ON INSPECTED ITEMS

- 6.3.2.1 An accredited Inspection body may attach an inspection label containing the accreditation symbol to the items inspected using the inspection services covered by its scope of accreditation.
- 6.3.2.2 Inspection labels containing the accreditation symbol shall not give the impression that the accreditation body approved or inspected the item.
- 6.3.2.3The inspection label shall include the following information:
 - a) The name of the accredited inspection body;
 - b) The accreditation number of the accredited inspection body;
 - c) The equipment identification;
 - d) The date of the inspection
 - e) A clearly indication that the item has been inspected, e.g., "inspected by ..," or inspected on ..." etc. In addition;
 - f) Cross reference to the inspection report issued in respect of the inspection

6.3.3 REFERENCE MATERIAL DOCUMENTS AND LABELS

- 6.3.3.1 RM certificates and RM labels containing the accreditation symbol shall not give the impression that the accreditation body approved or produced the RM.
- 6.3.3.2 In addition to the information required in ISO 17034, the label would usually include the following:
 - a) The name and accreditation number of the accredited reference material producer;
 - b) Designation of the product and batch number;
 - c) Cross reference to the reference material certificate.

6.3.4 PROFICIENCY TESTING DOCUMENTS

Accredited PT providers may use the accreditation symbol on the documents related to the PT

schemes covered by the scope of accreditation of the PT provider.

6.3.5 CERTIFICATION BODIES

A certificate issued by an accredited certification body shall:

- a) Identify the accreditation body (PAC)
- b) Identify the certification body issuing the certificate
- **c)** Identify the number and title of certification standard, or other means of clearly identifying the scope of certification.

6.4 ADVERTISING AND PUBLICITY

Accredited bodies are permitted to use accreditation symbols or accreditation claims on website and in promotional materials such as publicity, advertising material, brochures, organizational publications provided that:

- a) The rules and requirement outlined in this document are met.
- b) where an accreditation symbol is printed on letterhead and/or other corporate paper, such items are not used for work proposals or quotes if none of the activity is within the scope of accreditation, nor for reporting of conformity assessment results if none of them are within the scope of the accreditation, nor for certifying a product or item
- c) the accreditation claim is related to or associated with only the conformity assessment activities that are covered by the scope of accreditation, and not with any other activities in which the CAB or its related organisation may be involved. In proposals or quotations, it is necessary to distinguish conformity assessment activities that are covered by the scope of accreditation from those which are not;
- d) Promotional materials are approved by PAC in advance in writing to PAC Accreditation Manager prior to publication and distribution.

6.5 MISUSE OF ACCREDITATION SYMBOL OR ACCREDITATION STATUS

6.9.1 PAC will treat seriously any incompliance with its requirement regarding use of accreditation symbol or claim of accreditation

6.9.2 The action taken by PAC to deal with incorrect or unauthorized claims of accreditation status, or misleading or unauthorized use of accreditation symbols and the accreditation body logo can include:

- a) requests for corrective action,
- b) suspension,

- c) withdrawal of accreditation,
- d) publication of the transgression and,
- e) if necessary, legal action.
